White or blue granule. The "indicating" material has some blue "indicator" granules mixed throughout to indicate moisture level. Odorless.

SECTION 4 — FIRST AID MEASURES

Flinn Suggested Chemical Storage Pattern: Inorganic #2. Store with acetates, halides, sulfates, sulfites, thiosulfates, and phosphates. Store in a cool, dry place. Deliquescent; store in Flinn Chem-Saf Bag.

Avoid contact with eyes, skin, and clothing. Wear chemical splash goggles, chemical-resistant gloves, and a chemical-resistant apron. Use exhaust ventilation to keep airborne concentrations low.
