Potential Health Effects (Acute and Chronic): Prolonged or repeated skin contact may cause dermatitis.

SECTION 4: FIRST-AID MEASURES

Emergency and First Aid Procedures:

In Case of Inhalation: If inhaled, remove to fresh air. If breathing is difficult, give oxygen. If breathed in, move person into fresh air. Consult a physician.

In Case of Skin Contact: Flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Get medical aid immediately. Wash clothing before reuse. Wash off with soap and plenty of water. Consult a physician.

Suitable Extinguishing Media: Substance is noncombustible; use agent most appropriate to extinguish surrounding fire. Use water spray, dry chemical, carbon dioxide, or alcohol-resistant foam.

incompatible substances. Keep away from metals. Corrosives area. Keep away from acids. Containers must be tightly closed to prevent the conversion of NaOH to sodium carbonate by the CO₂ in air.
